Terms & Conditions

Credit Approval/Account Setup

All Adirondack Energy Products Inc. accounts must be credit approved. An authorized agent of Adirondack Energy Products Inc. will use the information provided to verify credit through an outside credit reporting agency. The credit application will remain on file as long as you remain a customer. All information provided is for Adirondack Energy Products Inc.'s use only and will not be shared with any outside parties.

Lock In Pricing/Terms and Conditions

Customer understands that upon execution of this agreement, Adirondack Energy Products Inc. may enter into contracts or arrangements to obtain a secure supply of the committed gallons to supply customer at the Lock In Price. The customer will be billed for any gallons not used under this contract. **If Customer is more than 30 days late in payment, Lock In Price will default to Market Pricing if higher.**

General Terms & Conditions of Payment

Adirondack Energy Products Inc. requires payment in full within 30 days of your delivery or prior to your next delivery. No deliveries of any product will be made if there is a balance owing on the account.

If payment is not received within 30 days from the date of delivery then you will receive written and/or verbal notice that the tanks will be picked up, due to non-payment. Any costs and/or fees accrued as a result of tank pick up will be the responsibility of the customer.

If full restitution is not made on purchases, within 60 days and no other payment agreement can be reached, Seller reserves the right to charge the credit card on file or perform and E.F.T. payment using your bank information to secure the balance past due on the account. Adirondack Energy Products Inc. reserves the right to proceed with collections through a 3rd party agency or take civil action against you in a court of law at customer's expense if necessary. Adirondack Energy Inc. also reserves the right to charge a D&S fee on every delivery without notification to the customer.

Tank Rental Fees/Minimum Purchase Requirements

By signing this contract you are agreeing to a minimum yearly (April 30th – May 15th) purchase requirement described below. These requirements will take effect beginning January 1st of the year following the contract date. As long as the purchase requirement described below is met then no additional rental fees will be charged.

Required Purchase Requirement	200 lb Tank – 50 Gallons Per Year
	420 lb Tank – 200 Gallons Per Year
	330 lb Tank – 400 Gallons Per Year
	500 lb Tank – 500 Gallons Per Year

In the event a customer fails to meet the minimum purchase requirements, Adirondack Energy Products Inc. reserves the right to charge a rental fee for the shortfall gallons. The shortfall gallons are equal to the difference between your usage and the required yearly purchase amount listed above. The amount of shortfall gallons will be multiplied by your then current price per gallon for propane to achieve the amount of the tank rental fee. Account reviews will be in the month of January and any applicable rental fees will be billed at this time.

If you are not the legal owner of the property on which the tank is set (tenant), you are required to pay a \$150 security deposit. Adirondack Energy Products Inc. reserves the right to retain this deposit in the event of termination/default of contract.

Termination/Default of Contract

Adirondack Energy Products Inc. reserves the right to terminate this contract at any time for any of the following reasons:

- Fails to Maintain an acceptable credit rating with Adirondack Energy Products Inc. or is otherwise in arrears in any bill due to Adirondack Energy Products Inc. or its service representatives.
- Misuse and/or damage of Adirondack Energy Products Inc. equipment.
- Fails to meet minimum yearly gallon purchase requirements

In the event of termination of service whether requested by Adirondack Energy Products Inc. or the customer, a fee of \$1.00 per gallon will be charged for all gallons remaining in the tank at time of pick up and/or a \$100 pick up fee. If any of these fees apply, customer agrees to pay these fees within 10 days from date of tank pick up.
